How to Use


1. Hearing headset and Remote Microphone Charging

There is a 2 ports charging cable inside, you can charge the headset and remote microphone at the same time, charging time is around 1hr. When the headset is on charging, the green light will flash quickly and keep on after full charged.

When the remote microphone is on charging, the white light will keep cycle flashing and keep on after full charged.

(*Power adapter not included, please use regular 5V DC adapter)


(We recommend you full charge the device before first use)

Note: Make sure the headset is turned off before wearing i






7. Clear the Bluetooth Paired Record


Under the Bluetooth mode, keep clicking the power button 3 times to clear the paired record, and the headset will turn of automatically.

8. Battery Low Reminder

When the headset is under low battery, there is a prompt tone" battery low", it reminds you to charge the headset. When the remote microphone is under low battery, the left side white light will flash fast, it reminds you to charge the remote microphone.
